- 12. **USE OF PARKING SPACE**. The Parking Space shall be used for parking purposes only. Parking vehicles deemed hazardous due to leaking fluids or otherwise in poor condition is strictly prohibited. No storage of goods, materials, or other items shall be permitted in the Parking Space without prior written consent from the Landlord.
- 13. **INSURANCE**. Any vehicle using the Parking Space by the Tenant shall be required to have it insured at all times and provide such documentation for insurance upon request by the Landlord. Insurance must meet the minimum requirements as required under Governing Law.
- 14. **INDEMNIFICATION**. The Tenant agrees to indemnify, defend, and hold the Landlord harmless from any claims arising from the Tenant's use of the Parking Space, except for those caused by the Landlord's negligence.
- 15. **DEFAULT**. If the Tenant fails to perform or fulfill any obligation under this Agreement, the Tenant shall be in default. Subject to any statute, ordinance, or law to the contrary, the Tenant shall have 5 business days from the date of notice of default by the Landlord to cure the default. In the event the Tenant does not cure the default, the Landlord has the right to hire a tow company and remove the Tenant's vehicle from the Parking Space. Any fees related to the removal of the vehicle from the Parking Space shall be the responsibility of the Tenant.
- 16. **TERMINATION**. Upon the termination of this Agreement, the Tenant shall vacate the Parking Space and return it in the same condition as when the Term began, reasonable wear and tear excepted. If the Tenant's vehicle is not removed from the

Parking Space upon termination, the Landlord has the right to remove the Tenant's vehicle from the Parking Space and charge the Tenant for such fees for removal.

- 17. **GOVERNING LAW**. This Agreement shall be governed by and construed in accordance with the jurisdiction where the Parking Space is located ("Governing Law"). The Parties hereby irrevocably consent to the exclusive jurisdiction and venue of the federal and state courts located in the Governing Law for any disputes arising from or related to this Agreement.
- 18. **SEVERABILITY**. If any provision of this Agreement is deemed invalid, illegal, or unenforceable, the remaining provisions shall continue and remain in effect. Any invalid provision will be replaced with a valid one that most closely matches the intent of the original provision.

19. ADDITIONAL TERMS & CONDITIONS.

20. ENTIRE AGREEMENT. This Agreement constitutes the entire agreement between the Parties with respect to the subject matter herein and supersedes all prior agreements, understandings, negotiations, and discussions, whether oral or written, of the Parties. No modification of or amendment to this Agreement, nor any waiver of any rights under this Agreement, will be effective unless in writing signed by the Parties hereto. This Agreement may not be amended except by an instrument in writing signed by both Parties.
